## Background & Charge

- Academic Senate request to address:
- 1. Model Syllabus Language defining student use of AI
- 2. Relationship between AI resources and academic integrity standards
- 3. Availability and accessibility standards for AI tools for students and employees

-funding, training, support, etc

-generative AI vs. other AI tools (google translate/grammerly)

- 4. Intersectionality of AI, equity, privacy, and copyright
- Communication and sharing modes for information regarding AI -newsletter/workshop/canvas shell

-Communication to both employees and administrators.

-Staff development opportunities

- 6. Target date for implementing clear standards and policies.
- Updates to APs and BPs as needed.

### 1. Model Syllabus Language

- Initial drafting could begin in COOL meetings
- Faculty are 10-month employees, so this would need to begin in the Fall if we use the COOL Committee Subcommittee
- Any formal language would need Senate review & approval in Fall 2025

### 2. Academic Integrity Standards

- Academic Senate approved updates in March 2025
- Updated language published on De Anza website
- Forms a strong foundation for AI-related academic integrity discussions



### 3. Availability & Accessibility of AI Tools

- Equity of access for students & employees
  - Student and faculty focus groups or a campus wide survey would be helpful here
- Funding for vetted AI tools & licenses
- Training & support across campus
- Distinction between general AI & generative AI

# 4. Al, Equity, Privacy, & Copyright

- Complex, evolving area
- Recommend creating a working group:
  - • DEI
  - • DSPS
  - Tech Services
  - Library Faculty
- Goal: Build inclusive, ethical policy & practices

### 5. Communication & Professional Development

- Current work (Amy & Sal, PD Office):
  - AI Workshop Series
  - AI Canvas Hub
  - PD Newsletter + Flex activities
- Sustainability Need:
  - Dedicated AI Coordinator or Liaison (funding or reassigned time)
  - Ongoing quality, curation, and community engagement

#### **Question to Senate:**

– Is the Senate willing to support funding or reassigned time for this role?

### 6. Implementation Timeline

- Fall 2025: Draft standards ready for Senate and campus discussion
- Winter/Spring 2026: Final AP/BP updates and implementation
- Work aligned with district legal vetting

### 7. Updates to APs & BPs

- Requires district collaboration
- Must follow legal guidance
- To be sequenced after campus policy framework is developed

### Summary of Needs

- To achieve outcomes, we need:
- **Solution** Funding or reassigned time for AI Coordinator / Liaison
- Faculty task force stipends or support (3–5 faculty/staff)
- Sudget for AI tool licenses & accessibility
- Cross-campus collaboration with DEI, DSPS, PD, IT, Library
