<p>What is the program's Mission Statement?</p>	<p>The Puente Project, a retention and transfer program sponsored by the University of California Office of the President and California Community College Chancellors Office serves all students interested in transferring to a 4-year university. The program provides the students three components consisting of: English and Human Development-Counseling courses, Counseling and Mentoring for their first year and Counselor follow-up until the student transfers. The mission of the program is to increase the number of educationally disadvantaged students who enroll in four-year colleges and universities, earn college degrees and return to the community as mentors and leaders of future generations.</p>	
<p>Have you made any significant changes in your program based on the feedback you received from the SSPBT's review of your 2011-12 APRU?</p>	<p>Yes. We revised two of our SSLO's to reflect upcoming changes based on the Student Success Act and to incorporate a new technology tool - Degreeworks as a way to monitor student's educational progress.</p>	<p>Include anything done in direct response to the SSPBT feedback on the 2011-12 APRU. <p>What Impact have these significant changes had on your program?</p>	<p>Incorporating these changes helped to concentrate counseling, instruction and coordinating efforts to monitor student's progress more efficiently. We began to introduce Degreeworks as a planning tool for students.</p>	<p>Please explain how these significant changes have impacted your program. What is now different?</p>

What Impact have these significant changes had on your students?	First year student's met with counselor more frequently to determine career interests, major, transfer universities and to incorporate them in a year long educational plan and will be submitted on Degreeworks by July 2013.	Please explain how these significant changes have impacted your students, including any positive or negative consequences.
Have you initiated anything new to your program since the 2011-12 APRU?	We continued for the second year to link the EWRT 1A and Career and Life Planning courses to focus on Migration, Families and Work. We expanded and integrated family work history and careers into our mentoring component at the winter quarter mentor-student gathering. This helped us to link all three components more smoothly.	This is similar to the above question about significant changes but is meant to single out any new initiatives.
Is there anything else the SSPBT should know about what has happened in your program since the 2011-12 APRU?	Students were able to complete various self assessments (skills, interests, personality and academic majors and career clusters) at no costs because of the material fees fund. This really benefitted our students because many are from low income families and may not have the funds to pay for such assessments. Next year, the counseling material fees will no longer exist. <p>Have you completed a <b>SSLOAC</b> in 2012 - 13?</p>	<p>SSLO #1 - The counselor is currently meeting individually with each student to develop an educational plan for transfer. To date, 70% of the students have met with counselor and have a minimal year long educational plan for transfer. Incorporated in the major and career interest survey questions #5 and #6 pertain to educational plans and transfer. To date, 90% of the respondents have met with counselor and of those 100% concluded their educational plans included general education and major requirements for transfer.</p> <p>SSLO #2 - To assess whether students were able to identify a career area or major as a result of the program, we created a Major and Career Interest Survey. 79% of the student's reported that Puente helped to identify an academic major. 90% of the student's reported that Puente helped to identify a career field. Student's reported various activities that helped them to define their interests and they include but not limited to: workshops attended during college trips, working with our mentors, the personality and career surveys taken in class, attending the Latin@ Mayors event on campus, and counseling class. This confirms that career exploration needs to begin at orientation when students arrive on campus and that it has to go beyond the classroom and counseling office. Also, there is a need to develop activities utilizing Degreeworks early on as well.</p> <p>SSLO #3 -The assessment tool used to evaluate the final essay demonstrated that most Puente students were able to compose college-level essays by then end of the 2013 Winter quarter, which included integration between EWRT 1A and CLP 70. The criteria upon which the were evaluated includes: Critical Thinking/Content, Thesis, Organization, Development, and Mechanics/MLA. Amongst the criteria, students were most successful with Critical Thinking/Content, Thesis, and Organization and need to continue to work on Development and Mechanics/MLA, which they will continue to do in their subsequent EWRT 1B and/or EWRT 2 classes. Current date shows that 27 students passed the class and 2 will be required to repeat it.</p>	<p>If yes, please summarize the results, discussions, analyses, and any improvement plans that do not involve any new resources to implement.</p> <p>If no, please give an update of your progress or future assessment plans.</p>
