Resident and Non-Resident Enrollment

- Total enrollment increased by 2% and total FTES each increased by 4%.
 - Total FTES increased by 166 from 4,643 to 4,809.
- Resident enrollment increased by 1% and FTES by 2%.
 - FTES increased by 67 from 4,114 to 4,181.
- Non-resident enrollment is up 12% and FTES is up 19%.
 - FTES increased by 99 from 529 to 628.

Resident and Non-Resident Enrollment by Category

- Among the resident category, the increase to its overall FTES is driven by the resident subgroup, which had 86 more FTES compared to last year.
- Among the non-resident category, non-resident and international student subgroups' FTES increased, with the latter group having a larger increase of 62 FTES.

International Students with F1 Visa

- Headcount of students with F1 or FZ visas increased from 1,133 to 1,287, representing a 14% increase in F1 visa students from last Fall quarter.

- For fall 2024, online comprised the majority of enrollments (55.6%); however, its share of enrollment decreased from the prior year by 1.7 percentage points.
- Hybrid enrollments increased by 1,008, comprising 24% of enrollments.
- Face-to-face enrollments increased by 259 at 20.2% of enrollments by modality.

- The top three enrolled ethnic groups consisted of Asian (36%), Latinx (25%) and white (20%) students. Combined, they accounted for 82% of all fall 2024 students.
- The share of white students enrolled in fall 2024 increased by three percentage points, from 17% to 20%. The proportion of Asian students decreased by two percentage points from 38% to 36%.

- Two groups of students make up the largest proportion of students by age, students aged 19 or less (36%) and between the ages 20 and 24 (29%), comprising 65% of the population.
- Students between the ages 25 and 39 comprise 24% while those 40 and over comprise 11%.

Educational Goal

- Students with a goal of transfer comprised the majority of students in fall 2024 quarter (67%).
- Students who declare a goal of degree decreased slightly to 8%, while students who want to earn a certificate remained at 3%.
- Students with an educational goal other than transfer, degree, or certificate remained at 22%. The “all other” category includes vocational training and job recertification.
